RE: ASC Compliance Review of Mississippi's Appraiser Regulatory Program

Dear Mr. Praytor:

The Appraisal Subcommittee (ASC) staff conducted an ASC Compliance Review (Review) of the Mississippi appraiser regulatory program (Program) on June 23-25, 2015, to determine the Program's compliance with Title XI of the Financial Institutions Reform, Recovery, and Enforcement Act of 1989, as amended.

The ASC considered the preliminary results of the Review and the State's response to those results. The Program has been awarded an ASC Finding of "Needs Improvement." The final ASC Compliance Review Report (Report) is attached.

The ASC identified the following area of non-compliance:

 States must verify that the applicant has successfully completed courses consistent with AQB Criteria for the appraiser credential sought, whether for initial credentialing, renewal, upgrade or reinstatement.

ASC staff will confirm appropriate corrective actions have been taken through off-site monitoring and during the next Review. Mississippi will remain on a two-year Review Cycle.

Supervisory Appraisers must complete the Supervisory/Trainee course prior to supervising a trainee. Mississippi regulations do not recognize the requirement for applicants for the trainee (Intern) credential to demonstrate the completion of the Supervisory Appraiser/Trainee course. Supervisory appraisers must hold a Certified Appraiser credential in the jurisdiction in which the trainee practices for a minimum of 3 years. Mississippi regulations do not require a Supervisory Appraiser to hold a Mississippi certified credential for a minimum of 3 years prior to supervising. Supervisory appraisers shall not have been subject to any disciplinary action within any jurisdiction within the last 3 years that affect their legal eligibility to engage in appraisal practice. Mississippi regulations do not limit the supervisory appraiser from supervising if they were the subject of disciplinary action affecting legal eligibility to appraise during the previous 3 years. Supervisory Appraisers are limited to 3 trainees, unless a State program in the credentialing jurisdiction provides for progress monitoring. AQB Criteria require all credentials holders including Trainees to limit the hours of CE claimed for non-student participation to 50% of the CE amount required for the cycle; and complete 14 hours of CE per year.
